## Invitation to Bid for

### **PURCHASE OF THREE (3) UNITS VEHICLE FOR AGRICULTURE OFFICE**

The *Municipality of Calasiao*, through the **General Appropriations Act (Trust Fund)** intends to apply the sum of **Five Million Pesos (P5,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Purchase of Three (3) Units Vehicle for Agriculture Office (Reference No. 2025-01-049)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *Municipality of Calasiao*, through the **General Appropriations Act (Trust Fund)** intends to apply the sum of **Five Million Pesos (P5,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Purchase of Three (3) Units Vehicle for Agriculture Office (Reference No. 2025-01-049)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *Municipality of Calasiao* now invites bids for the **Purchase of Three (3) Units Vehicle for Agriculture Office (Reference No. 2025-01-049)**. Delivery of the Goods is required **Sixty (60) calendar days**. Bidders should have completed a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizen/sole proprietorship, partnership or organizations with at least sixty percent(60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens pursuant to RA No. 5183

4. Interested bidders may obtain further information from *Municipality of Calasiao* and inspect the Bidding Documents at the address given below from 8:00A.M.to 5:00P.M.
