Explanatory note

During the recent past few years, Local Government Unit of Calasiao thru the Sangguniang Bayan created new Departments/Office, and New Department Heads, without however creating their corresponding support staffs (administrative aids) – due to budgetary constraints (referring to salary ceilings on personal services).

To make the new departments/offices functional to deliver the much needed services, the above mentioned employees/administrative aides), were flocked out from their original designations (offices) and directed by means of Executive Orders or Memorandum Orders from the Local Chief Executive to "detailed services" to the office they are now (presently) assigned.


Now to make things therefore to be place in their proper perspective, this Ordinance No. 7, Series of 2024 is being enacted.

A public hearing has been conducted on September 9, 2024, by joint committees – where the following facts were clearly established;


1. That the employees mentioned have no objection to their new prospective assignments;
2. That there was no diminution of their salaries and benefits;
3. That there were no adverse effects on their personal status as permanent employees. Being administrative aides they have no supervisory powers anyway to their co-employees.
4. The employees being transferred submitted a written conformity to their new assignments;
5. That the Department Heads concerned are well informed with regard to the transfer of positions




