SUSPENDING WORK IN LOCAL GOVERNMENT
OFFICES AND CLASSES IN ALL PUBLIC SCHOOLS IN
THE MUNICIPALITY OF CALASIAO IN ALL LEVELS
AND LEAVING SUSPENSION OF CLASSES IN PRIVATE SCHOOLS

WHEREAS, the Municipality of Calasiao lost a great leader in the person of Mayor Mamilyn B. Agustin-Caramat;

WHEREAS, in her short term as Mayor, she has broken glass ceilings and made wonders for the LGU with her immeasurable accomplishments such as finally resolving in just one month the four-year problem plaguing the Material Recovery Facility of Calasiao; acquiring for the LGU important properties for the benefit of the Calasiaoenos; running a truly, genuinely clean, effective, and efficient governance with a benevolent heart, among many more achievements;

WHEREAS, Section 16 of the Local Government Code provides that Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

WHEREAS, the people of Calasiao, including local government employees shall lay to rest Calasiao's great Chief Executive and Mother, Mayor Mamilyn B. Agustin-Caramat on January 18, 2023 in the Garden of Eden, San Miguel, Calasiao;

WHEREAS, the LGU has to see to it that the great Chief Executive shall be laid to rest in a peaceful and orderly manner that is consistent with the preservation of public comfort and convenience, in accordance with Section 16 of the Local Government Code;

NOW THEREFORE, I, Mayor Kevin Roy Q. Macanlalay, by virtue of the powers vested in me by law, hereby declare the suspension of classes in all levels in public schools in the Municipality of Calasiao, Pangasinan and the suspension of work in government offices under the Local Government Unit of Calasiao, on January 18, 2023.

The discretion to suspend classes in private schools especially those situated on January 18, 2023 in Nalsian and Poblacion West, Calasiao, Pangasinan, are left to the discretion of their respective heads.

Likewise, the suspension of operations for private establishments on January 18, 2023 in the said territorial units under the Municipality of Calasiao shall be left to the sound discretion of the proprietors.
