RECONSTITUTION OF THE LOCAL YOUTH DEVELOPMENT COUNCIL

WHEREAS, Article 2 Section 13 of the 1987 Constitution states that, "the States recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual, an social well-being." It shall inculcate in the youth, patriotism and nationalism and encourage their involvement in public and civic affairs;

WHEREAS, it is declared policy of the locality to promote and protect the physical, moral, spiritual, intellectual, cultural and social well-being of the youth.

WHEREAS, Section 24, Rule III, IRR of RA 10742 provides that to ensure wide and multi-sectoral youth participation in local governance, there shall be in every province, city, and municipality a Local Youth Development Council (LYDC) which shall be called Provincial Youth Development Council, City Youth Development Council, and Municipal Youth Development Council. The LYDC shall be composed of representatives of youth and youth-serving organizations in the provincial, city, and municipal level. The LYDC shall assist the planning and execution of projects and programs of the Sangguniang Kabataan and the Pederasyon in all levels;

WHEREAS, it is the duty of the municipality to reach out to the youth in the barangay and to encourage them to actively participate and involved in the activities and programs;

WHEREAS, the Local Government Unit of Calasiao would like to ensure that the youth are given priority and that programs and policies is beneficial to them;

NOW THEREFORE, I, **KEVIN ROY Q. MACANLALAY**, **Municipal Mayor**, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Local Youth Development Council of Calasiao, furthering order the following:

SECTION 1. KEY FUNCTIONS OF THE LOCAL YOUTH DEVELOPMENT COUNCIL. The LYDC shall have the following functions:

- a. To serve as the core of the advocacy on youth participation in nation-building and youth empowerment;
- b. To develop and harness the full potential of the youth as responsible partners in nation-building;
- c. To encourage active participation in all government and nongovernment programs, projects, and activities for the youth;

- d. To broaden and strengthen the services to the youth;
- e. To provide monitoring and coordinating mechanisms for youth programs.

SECTION 2. COMPOSITION OF THE LOCAL YOUTH **DEVELOPMENT COUNCIL.** The LYDC shall be composed of the following:

SECTION 3. OTHER FUNCTIONS OF LYDC. The LYDC shall perform the other functions:

- a. To formulate policies and component programs in coordination with the various government agencies handling youth-related programs, projects, and activies;
- b. To develop and provide support for the development and coordination of youth projects and design strategies to gain support and participation for the youth;

- To implement programs aimed at developing the full potential of the youth;
- d. To empower the youth through heightened awareness on the various issued arising among youth;
- e. To formulate and submit Local Youth Development Plan;
- f. To perform other related functions that may be assigned by the Municipal Mayor.

SECTION 4. SECRETARIAT. The Local Youth Development Officer shall be the secretariat of the Local Youth Development Council.

SECTION 5. LOCAL YOUTH DEVELOPMENT PLAN. The council shall formulate and adopt a Local Youth Development Plan which shall be the basis for the implementation of Local Youth Development Programs and services in coordination with concerned agencies. These shall include but not limited to Youth Development Services.

SECTION 6. MEETINGS OF THE COUNCIL. The Council shall meet quarterly or as maybe deemed necessary. The Chairperson or his duly authorized representative shall preside in all the council meeting.

SECTION 7. REPEAL CLAUSE. All other policies or laws creating organizations, councils, or boards in the municipality which exists having similar program with the Local Youth Development Council are hereby repealed.

SECTION 8. EFFECTIVITY. This order hall take effect immediately.
