**RE-ORGANIZING THE MUNICIPAL COUNCIL FOR THE PROTECTION OF
CHILDREN OF CALASIAO, PANGASINAN**

WHEREAS, DILG Memorandum Circular No. 2002-121, dated August 5, 2002 provides for the organization and strengthening of the Local Council for the Protection of Children (LCPC) which will serve as an advocacy body of the Local Government Unit towards the promotion, development, and protection of children;

NOW THEREFORE, I, KEVIN ROY Q. MACANLALAY, Municipal Mayor, by virtue of the powers vested in me by law, hereby organize the organization of the Local Council for the Protection of Children (LCPC) as follows:

SECTION I. COMPOSITION. The Local Council for the Protection of Children (LCPC) shall be composed of the following:

SECTION 2. FUNCTIONS. The following are the functions are the Local Council for the Protection of Children (LCPC):

1. Formulate plans, programs and policies for children that are gender-fair culturally relevant and responsive to the needs of diverse groups of children from 0 to below 18 years of age;
2. Prepare Annual Work and Financial plan for children and recommend appropriations to the SB
3. Provide coordinative linkages with other agencies and institutions in the planning, monitoring and evaluation of plans for children;
4. Provide Technical Assistance and recommend financial support to the barangay council for the protection of children
5. Establish and maintain database on children in the municipality
6. Foster education of every child
7. Advocate for the establishment and maintenance of playgrounds, Day Care Centers and other facilities necessary for child and youth development
8. Recommend local legislations promoting child survival, protection, participation, and development especially on the quality of television shows, media prints and coverages which are detrimental to children and with appropriate funding support
9. Assist children in need of special protection and refer cases filed against child abuses to proper agencies/institutions;
10. Conduct capability building programs to enhance knowledge and skills handling children's programs;
11. Document barangay best practices on children
12. Monitor and evaluate the implementation of the program and submit quarterly status report to the Provincial Council for the Protection of Children (PCPC);
13. Perform such other functions as provided for in the ECCD and other child related laws.

SECTION 3. SECRETARIAT. The Municipal Social Welfare and Development Office, headed by Ms. Editha B. Gorospe- Municipal Social Welfare and Development Officer, shall be designated as the secretariat to the LCPC.

SECTION 4. FUNDING. Upon recommendation of this council, the Municipal Government of Calasiao shall provide funding for projects, programs, and activities for children and ensure that these are implemented

SECTION 5 EFFECTIVITY. This Executive Order shall take effect immediately.
