EXECUTIVE ORDER No. 20 Series of 2023

RE-ORGANIZING THE MUNICIPAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (MCAT VAWC) DEFINING ITS FUNCTIONS"

WHEREAS, Republic Act 9208 declares the Enactment of Measures and Development of Programs that will promote human dignity, protect the people from violence and exploitation, eliminate trafficking in persons, and mitigate pressures for involuntary migration and servitude of persons to ensure their recovery, rehabilitation and reintegration;

WHEREAS, Republic Act 9262 underscores the commitment on safeguarding the dignity of women and children while guaranteeing full respect of their human rights and to protect them from violence and threats to their personal safety and security;

WHEREAS, to establish and strengthen local structure that will collaboratively address the problem of trafficking and violence against women and their children;

WHEREAS, SEC. 6 ART.III as per rules and regulations implementing RA 9208, otherwise known as the "Anti-Trafficking in Persons Act of 2003;

NOW THEREFORE, I KEVIN ROY T. MACANLALAY, Municipal Mayor of the Municipality of Calasiao, Pangasinan by virtue of the powers vested in me by law, do hereby re-organize the Local Committee on Anti-Trafficking and Violence Against Women and their Children.

SECTION 2 FUNCTIONS. The following are the functions of the MCAT VAWC:

1. Institute policies and programs to protect women and children who are victims of trafficking and violence (formulate local ordinance and resolutions)

2. Create and establish systems on surveillance, investigation and rescue to ensure effective and efficient coordination

3. Undertake information, education and advocacy campaign against trafficking in persons and VAWC

- 4. Monitor and oversee the strict implementation of RA 9262 and other related laws for the protection of women and children and the IACAT AND IACVAWAC national plan of action
- 5. Implement the programs and activities as stated in the national plan of action

 ${\bf SECTION}$ 3 ${\bf SECRETARIAT}.$ The MSWDO shall serve as the secretariat of this committee

SECTION 4. FUNDING REQUIREMENT. The Municipal Government thru the SB shall allocate funds from the Gender and Development and other sources for the operation and implementation of programs, projects and activities of the committee.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately.
