Executive Order No. 23

AN ORDER CREATING THE TECHNICAL WORKING GROUP (TWG) OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) FOR THE FORMULATION AND REVISION OF PLANS AS REQUIRED BY LOCAL AND NATIONAL AGENCIES OF THE GOVERNMENT

WHEREAS, Section 16 of RA 7160, states that every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefore, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare;

WHEREAS, to ensure the continuity of the delivery of service to the people and to maximize the utilization of government resources and facilities to its full extent;

WHEREAS, planning provides guidance in the implementation of programs and policies which aims to strengthen local government units in the performance of its functions geared towards promotion of sustainable development anchored on the principle of good governance and resilient community;

WHEREAS, planning serves as a formulation of necessary actions to be undertaken for the promotion of general welfare. The conceptualization of measures and approaches in the four thematic areas of disaster risk reduction management with the institutionalization of best practices that ensures the capability of the community to withstand the impact of all hazard;

WHEREAS, accomplishments of these plans validate the Local Government Unit’s foresight on changing times and adaptation to demands in terms of economic sustainability, disaster resiliency and climate change adaptability;

NOW, THEREFORE, I, KEVIN ROY Q. MACANLALAY, Municipal Mayor of Calasiao by virtue of the power vested in me by laws, do hereby create the Technical Working Group (TWG) of MDRRMC for the formulation and revision of all plans as required by Local and National agencies of the government; to wit;

SECTION 1. COMPOSITION. The TWG of the MDRRMC shall be composed of the following:
