EXECUTIVE ORDER NO. 24, SERIES OF 2023

RECONSTITUTING THE MUNICIPAL NUTRITION COMMITTEE IN THE MUNICIPALITY OF CALASIAO

WHEREAS, Presidential Decree No. 491, Series of 1974, Creating a National Nutrition

Council and for other Purposes and shall be known as the Nutrition Act of the Philippines;

WHEREAS, in Section 2, under the declaration of policy, the Government of the Philippines hereby declared that nutrition is priority to be implemented by all branches of the

Government in an integrated function;

WHEREAS, the delivery of basic services including nutrition is devolved to the Local Government Units (LGUs);

WHEREAS, pursuant to Letter of Instructions No. 441, series of 1976, the Department of Interior and Local Government (DILG) is authorized to establish functioning nutrition committees at different administrative levels in barangay, municipality, city, province and region;

WHEREAS, The DILG requires for the assessment of the functionality of Provincial, Municipal & Barangay Nutrition committee.

NOW, THEREFOR, I, KEVIN ROY Q. MACANLALAY, Mayor of Municipality of Calasiao, Province of Pangasinan by virtue of the powers vested in me by law, do hereby reconstitute the Municipal Nutrition Committee composed and order the following:

- Formulate and implement local food and nutrition policies, plans and interventions for nutrition improvement;
- 2. Monitor and evaluate the efficiency and effectiveness of the plan for nutrition improvement;
- Identify and mobilize local resources for nutrition interventions;
- 4. Advocate local support for nutrition plan to sustain nutrition improvement.
