**EXECUTIVE ORDER NO. 25**

**CREATING THE CONTRACT TERMINATION REVIEW  
COMMITTEE AND ORDERING THE MUNICIPAL  
ENGINEER TO VERIFY THE EXISTENCE OF GROUNDS  
FOR THE TERMINATION OF CONTRACT PARTICULARLY  
THE CONSTRUCTION OF CALASIAO, SLAUGHTERHOUSE  
AT BRGY NAGSAING, CALASIAO, PANGASINAN**

WHEREAS, Annex "I," Item IV, paragraph 6 of the 2016 Implementing Rules and Regulations of Republic Act 9184 empowers the undersigned to create a Contract Termination Review Committee to assist him in the discharge of his functions in the Termination of Contracts in accordance with the Government Procurement Reform Act;

WHEREAS, the undersigned sees the need to employ such power for the expeditious and effective discharge of his functions;

NOW THEREFORE, I, KEVIN ROY Q. MACANLALAY, by virtue of the powers vested in me by law, hereby create a Contract Termination Review Committee and order the following:

**SECTION 1.** The Contract Termination Committee shall be composed of the following:

The Contract Termination Committee shall assist the local chief executive in the discharge of his functions in the Termination of Contracts in accordance with the provisions of pertinent laws and make recommendations in pursuance thereto, including the possible termination of the LGU's Slaughterhouse Project in Nagsaing, Calasiao, Pangasinan. The Contract Termination Committee is hereby further

directed to include in its recommendation (1) a determination of the person with whom the possible termination shall be dealt with, (2) the delays that entailed the project, if there be any; and (3) circumstances surrounding the other ground/s of termination of contract. The Contract Termination Committee is likewise directed to determine the existence of circumstances that make the project economically, financially or technically impractical/ unnecessary, and whether or not the termination of the contract should be total.

**SECTION 3.** Since there may be acts which may constitute grounds for termination of the Slaughterhouse Project in Nagsaing, Calasiao, Pangasinan, the Implementing Unit, namely the Office of the Municipal Engineer is hereby ordered to make verification as to the existence of the said grounds. The Municipal Engineer is further ordered to submit his report on his verification to the Contract Termination Committee.

**SECTION 4.** This Order shall take effect immediately.
