**DIRECTING THE CONDUCT OF PRE-EMPTIVE OR
FORCED EVACUATION IN AREAS OF THE
MUNICIPALITY DECLARED TO BE IMMINENT DANGER**

WHEREAS, the general welfare clause of Republic Act 7160 otherwise known as the Local Government Code States that “Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and persevere the comfort and convenience of their inhabitants”;

WHEREAS, Republic Act No. 10121, (An Act Strengthening the Philippine Disaster Risk Reduction and Management System, Providing for the National Disaster Risk Reduction and Management Framework and Institutionalizing the National Disaster Risk Reduction and Management Plan, Appropriating Funds therefore and for the Purposes) fosters the adoption of preventive measures to reduce the vulnerabilities of human lives and properties to disaster;

WHEREAS, the Municipal Government strongly recognizes the value of mitigating the adverse effects and prevent the loss of human lives during disasters by adopting emergency measures such as preemptive or forced evacuation in its bid for zero casualties during disasters;

NOW THEREFORE, I, KEVIN ROY Q. MACANLALAY, Municipal Mayor of the Municipality of Calasiao, Province of Pangasinan, by virtue of the powers vested in me by law, do hereby order and direct:

Section 1. The conduct of preemptive or forced evacuation in areas declared to be in imminent danger in times of disaster.

Section 2. The Barangay Disaster Risk Reduction and Management Committees shall carry out the preemptive or forced evacuation upon the recommendation of the Municipal Disaster Risk Reduction Management Council.

Section 3. The evacuation centers shall be those that were previously identified by the Barangay Disaster Risk Reduction and Management Committees and reported to the Municipal Disaster Risk Reduction Management Council.

Section 4. The assistance of the Philippine National Police (PNP), Bureau of Fire Protection, and other agencies shall be solicited when needed.

Section 5. The forced evacuation should be carried out in a manner that is humane, respectful of the dignity of person, not using disproportionate force, without discrimination and with conscious attention to the needs of vulnerable sectors such as children, women, the elderly, and persons with disabilities.

Section 6. This Executive Order shall take effect immediately.
