**CREATING A TASK FORCE TO MITIGATE AND  
ADDRESS THE EFFECTS OF EL NIÑO PHENOMENON  
IN THE MUNICIPALITY OF CALASIAO**

**WHEREAS**, DOST-PAGASA has raised the El Niño Southeastern Oscillation (ENSO) Alert and Warning System to El Niño Watch based on the recent conditions and forecast models indicating that the El Niño season will likely develop in July-August-September 2023 and may persist until 2024;

**WHEREAS**, precautionary measures have to be taken to address the dire effects of the El Niño Phenomenon in the municipality, for the protection of the inhabitants of Calasiao;

**NOW THEREFORE, I, KEVIN ROY Q. MACANLALAY**, Mayor of the Municipality of Calasiao, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1.** There Municipal Task Force for the Mitigation of the Effects of El Niño Phenomenon in the Municipality of Calasiao is hereby created, which shall be composed of:

**SECTION 3.** The Municipal Task Force for the Mitigation of the Effects of the El Niño Phenomenon shall have the primordial task of taking all measures and courses of action that are necessary to mitigate, address and prepare for the ongoing and potential adverse effects of El Niño in the Municipality of Calasiao.

**SECTION 4.** The Vice Chair Mr. Freddie Villacorta who is concurrently the head of the LDRRMO is hereby directed to come up with a grand action plan integrating and streamlining all plans submitted by the concerned sectors, particularly by the heads of the concerned department/s, namely **agriculture and livestock, environment and fire prevention, social welfare and health**. The plans to be submitted by the MHO, MAO, MSWDO and MENRO (in coordination with the Fire Marshall and OIC-PNP Calasiao) shall indicate the time frame for the courses of action to be taken and its proposed budget allocations.

In coming up with the plans, the Vice Chair and the members of the Task Force are hereby directed to coordinate with their respective counterpart agencies including the PDDRMO, Regional Office of the National Economic and Development Authority, Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD), through the Regional Offices of the DOST, PHO, PENRO, and PSWDO for the aligning of the actions to be undertaken.

**SECTION 5.** Budget Officer Madam Leticia Garcia and MPDC Engr. Evelyn C. Siapno are hereby directed to integrate in regular local plans and regular local budget, programs, projects and allocations in consonance with the foregoing action plan, in coordination with the Task Force, in light of the budgetary constraints under the MDRRMO.

**SECTION 6.** BFP Marshall SINSP Gener Santos Ramos, PNP OIC PLTCOL. James Patrick M. Calibuso and MENRO Mr. Mark Paolo Caspillan are hereby directed to intensify campaigns and programs on fire prevention and water conservation in the Municipality of Calasiao.

**SECTION 7.** The Municipal Task Force for the Mitigation of the Effects of El Niño Phenomenon is hereby ordered to strengthen effective information drives on El Niño and its effects. The information drives shall form an integral part of the consolidated action plan.

**SECTION 8.** The Municipal Task Force for the Mitigation of the Effects of El Niño Phenomenon is hereby likewise ordered to come up with measures for the benefit of the studentry of the Municipality of Calasiao, having in mind that the national law and administrative issuances hold primacy over matters that are dealt and treated by them.

**SECTION 9.** Regular meetings ensuring the implementation and the fine-tuning of the consolidated action plan shall be conducted at least once a month and as directed by the undersigned or the Vice Chair.

**SECTION 10.** Vice Chair MDRRMO Mr. Freddie Villacorta is hereby directed to invite in the forthcoming meetings representatives from DECORP and water utilities operating in the municipality.

**SECTION 11.** This order shall take effect immediately.
