EXECUTIVE ORDER NO. 35
Series of 2023

**ESTABLISHING AN OPERATION CENTER UPON IMPENDING CALAMITIES,
DISASTERS AND EMERGENCIES IN THE MUNICIPALITY OF CALASIAO**

WHEREAS, RA 10121 is "An Act Strengthening the Philippine Disaster Risk Reduction and Management System (PDRRMS), Providing for National Disaster Risk Reduction and Management (NDRRM) Framework and Institutionalizing the NDRRM Plan, Appropriating Funds Therefor and for other purposes.

WHEREAS, RA 10121, Section 9 (g) Office of the Civil Defense (OCD) shall establish Standard Operating Procedure for coordination.

WHEREAS, RA 10121, Section 12 C, Sub-paragraph (23) mandates every LGU's to establish DRRM Operation Centers.

WHEREAS, RA 10121, Section 12, Par. (c), Sub-par (16) mandates the Local DRRMO to "Respond to and Manage the adverse effects of emergencies and carry out recovery activities in the affected area, ensuring that there is an efficient mechanism for immediately delivery of food, shelter and medical supplies for women and children..."

NOW THEREFORE, I, KEVIN ROY Q. MACANLALAY, Mayor of the Municipality of Calasiao, by virtue of the powers vested in me by law, do hereby order the establishment of DRRM Operation Center to respond to emergencies, disasters and calamities in the Municipality of Calasiao and hereby order as follows:

SECTION 1- DEFINITION OF TERMS:

1. OP CEN - Operation Center
2. MDRRMC – Municipal Disaster Risk Reduction and Management Council
3. MDRRMO - Municipal Disaster Risk Reduction and Management Office
4. LDRRMO – Local Disaster Risk Reduction and Management Officer
5. LCE – Local Chief Executive
6. Personnel – All response teams other than LGU response team members

SECTION 2 – STANDARD OPERATING PROCEDURE

1. The undersigned hereby orders the activation of the OP CEN.
2. The OP CEN shall be manned by the LDRRMO's and staff on a 24 hour basis.
3. The OP CEN shall serve as the center of operation in managing the specific disaster, calamity or complex emergency in the municipality.
4. The LDRRMO on duty shall receive directions directly from the LCE.
5. All responders and personnel on the standby or active mode shall receive direct orders from the OP CEN.
6. Upon the recommendation of the MDRRMC, that the peril or risk has ceased to exist, the LCE may order the deactivation of the OP CEN.

SECTION 3 – REPEALING CLAUSE. All other issuances inconsistent with this Order are deemed repealed.

SECTION 4 – EFFECTIVELY. This Executive Order shall take effect immediately.
