**AN ORDER CREATING THE CALASIAO HEALTH EMERGENCY
RESPONSE TEAMS (HERTS) OF THE MUNICIPAL HEALTH
OFFICE AS PART OF THE DISASTER RISK REDUCTION AND
MANAGEMENT FOR HEALTH (DRRM-H) PLAN**

WHEREAS, the enactment of Republic Act 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 has laid the basis for the disaster risk reduction and management (DRRM);

WHEREAS, the Local Government Units (LGUS) are, based on the Local Government Code (Republic Act 7160) and Philippine Disaster Reduction and Management Act (RA 10121), at the forefront when it comes to addressing health services and disaster preparedness as well as in strengthening responsiveness of local health systems to address disaster-related health impacts;

WHEREAS, the Local Government Units, with guidance from the Department of Health (DOH), are directed to develop Health Resiliency or "the capacity of a health system to absorb, adapt and transform when exposed to a shock such as pandemics, natural disasters or armed conflict and still retain the same control on its structure and functions"

WHEREAS, the Local Government Unit of Calasiao, Pangasinan has deemed it essential to institute the convergence of services from the different line agencies to support Republic Act 10121 in its objective of achieving "Safer, adaptive and disaster resilient Filipino communities towards sustainable development";

WHEREAS, the Local Government Unit of Calasiao, Pangasinan will include the Disaster Risk Reduction Management Plan for Health (DRRM-H) as platform for policies, plans, programs and strategies to reduce health risks due to disasters and ultimately lead to health resiliency;

WHEREAS, in order to strengthen the Calasiao Disaster Risk Reduction and Management for Health, there is a need to create Health Emergency Response Teams in the Municipal Health Office in order to take charge of the aforementioned tasks;

NOW, THEREFORE, I, KEVIN ROY Q. MACANLALAY, by virtue of the powers in me vested by law as Municipal Mayor of Calasiao, Pangasinan hereby order the following:
