### EXECUTIVE ORDER NO. 50 SERIES OF 2023

### ORGANIZING THE CENSUS OF AGRICULTURE AND FISHERIES MUNICIPAL CENSUS COORDINATING BOARD OF THE MUNICIPALITY OF CALASIAO

WHEREAS, Executive Order (EO) No. 352, otherwise known as the Designation of Statistical Activities That Will Generate Critical Data for Decision-Making of the Government and the Private Sector, issued on 01 July 1996, designates the regular conduct of the Census of Agriculture and Fisheries (CAF) every ten years with the objective of providing government planners and policy makers with data on which to base their plans for the country's development;

WHEREAS, Section 6 of Republic Act (RA) No. 10625, otherwise known as the Philippine Statistical Act of 2013 mandates the Philippine Statistics Authority (PSA) to prepare and conduct periodic censuses on population, housing, agriculture, fisheries, business, industry and other sectors of the economy;

WHEREAS, the latest CAF was undertaken in 2013 with 2012 as reference year and the next census will be conducted in September 2023 with 2022 as reference period to come up with data on agricultural and fisheries structures; to provide sampling frame for other statistical undertaking; and to provide basic data for use in national as well as local development planning;

WHEREAS, recognizing the increasing importance of the census data in meeting data needs at the lowest geographic level, the assistance provided by government agencies, government-owned and controlled corporations, and local government units (LGUs) to the PSA, as in previous censuses, will be instrumental to the success of the 2022 CAF;

WHEREAS, one of the functions of the PSA Board per RA 10625 is to prescribe appropriate frameworks for the improvement of statistical coordination and establish mechanisms for statistical coordination at the regional and LGU levels;

WHEREAS, to ensure the cooperation of all government and private entities and smooth flow of census operations at local level, there is a need to create provincial, city, and municipal census coordinating boards;

**NOW, THEREFORE, I, KEVIN ROY Q. MACANLALAY,** Municipal Mayor, by virtue of the authority granted to me by law and in compliance with relevant rules and regulations do hereby organize the Census of Agriculture and Fisheries (CAF) Municipal Census Coordinating Board (MCCB) of the Municipality of Calasiao, Pangasinan further ordering the following:

Section 1. Composition. The Municipal Census Coordinating Board for 2022 CAF of the Municipality of Calasiao, Pangasinan is composed of the Municipal Mayor as Chairperson and the <u>PSA CAF Focal Person as</u> the Vice-Chairperson with the following members:

Section 2. Terms of Reference. The following are the functions of Census of Agriculture and Fisheries (CAF) Municipal Census Coordinating Board (MCCB) of the Municipality of Calasiao, Pangasinan:

- 1. Assess the needs of PSA in the province in terms of training, transportation, communication, security, and publicity;
- 2. Make an inventory of the training, temporary headquarters, transportation, and communication facilities that may be made available for use in the census operations;
- 3. Provide inputs for census technical materials such as list and concepts/ definitions of agricultural crops/practices;
- 4. Provide list of agricultural/ fishery associations and programs;
- 5. Specify the areas of involvement and participation of other agencies and the limits of their resources;
- 6. Conduct of publicity and information campaign;
- 7. Assist PSA in the census operations to ensure complete coverage of the municipality; and
- 8. Take up other matters as may be specified by the PSA or as necessary for the successful conduct of the census.

Section 3. Frequency of Meeting. CAF MCCB meetings shall be held at least once every quarter.

Section 4. Repealing Clause. All former Executive Orders or issuances inconsistent with the provisions of this Executive Order are hereby amended or modified accordingly.

Section 5. Separability Clause. In case any provision in this Executive Order be declared unconstitutional, contrary to law and public policy and invalid, the legality and enforceability of the remaining provisions are not affected and impaired thereby.

Section 6. Effectivity. This Order shall take effect immediately.
