**CREATING THE HRMPSB FOR VACANT POSITION IN
THE OFFICE OF THE SANGGUNIANG BAYAN**

WHEREAS, Sangguniang Bayan ng Calasiao Resolution No. 30 Series of 2022 established the Human Resource Merit Promotion and Selection Board of the Municipality of Calasiao, Pangasinan;

WHEREAS, Memorandum Circular No. 14 Series of 2018 particularly the last paragraph of Section 88 thereof provides that the agency head shall issue an Office Order identifying the principal members of the HRMPSB;

WHEREAS, Section 90 of the said circular pertinently provides that "the membership of the HRMPSB can be modified, provided it conforms to the prescribed composition. Agencies may add a reasonable number of members, but the prescribed composition may not be reduced.

WHEREAS, Section 80 (c) of the Local Government Code provides that

Section 80. Public Notice of Vacancy; Personnel Selection Board. -

X X X

(c) The personnel selection board shall be headed by the local chief executive, and its members shall be determined by resolution of the sanggunian concerned. A representative of the Civil Service Commission, if any, and the personnel officer of the local government unit concerned shall be ex officio members of the board.

WHEREAS, by virtue of Special Order No. 1, Madam Jacel C. Dion was designated as OIC-HRMO;

WHEREAS, the Omnibus Rules on Appointment declare that for vacant positions in the Office of the Sangguniang Bayan, the HRMPSB shall be headed by the Vice Mayor;
