**ORGANIZING THE TECHNICAL WORKING GROUP FOR THE
IMPLEMENTATION PROCESSES OF THE LIVELIHOOD SETTLEMENT
GRANT (LSG) AND PREPARATION OF THE LIVELIHOOD RECOVERY
PROJECT PROPOSAL (LRPP).**

WHEREAS, the Department of Social Welfare and Development (DSWD) will be implementing the provisions of the Livelihood Settlement Grant (LSG) as part of its mandate as the lead government agencies during disaster relief, recovery, and rehabilitation. Moreover, the Department provided technical assistance and resource augmentation to the Local Government Units especially when disasters are enormous scale and intervention of the national government is needed. Such disasters include the Super Typhoon Yolanda (Haiyan) in 2013, COVID-19 pandemic in 2019, and just recently the Typhoon Egay (Doksuri).

WHEREAS, LSG aims to assist the economic recovery and rehabilitation of the livelihood and/or sources of income of the families which were affected by typhoon "Egay".

WHEREAS, the Local Government Unit of Calasiao, Pangasinan is one of identified for the implementation of the SAP-LAG;

WHEREAS, there is a need to organize a Technical Working Group (TWG) to ease the process relating to the provision of LSG;

NOW, THEREFORE, I, KEVIN ROY Q. MACANLALAY, Mayor of Calasiao, Pangasinan, by virtue of powers vested in me by law, do hereby order the following:

SECTION 1. ORGANIZATION OR ESTABLISHMENT. The Technical Working Group for the Implementation Processes of the Livelihood Settlement Grant is hereby organized/ established.

SECTION 2: COMPOSITION. The Technical Working Group shall be composed of the following:

SECTION 3. FUNCTIONS AND DUTIES OF THE TECHNICAL WORKING GROUP. The Technical Working Group shall have the following duties and functions:

- a. Identify target recipients conducted at the barangay level based on the criteria set by DSWD
- b. Conduct cross-matching of the target recipients vis-à-vis Listahanan database.
 - If the target beneficiary is not included in the Listahanan database, TWG may appeal through an official communication letter to the DSWD Field Office for the issuance and administration of the SLP-Mean Test to be filled out by the target beneficiary and the results must be encoded in the database as well.
- c. Propose livelihood programs suitable for each target recipient.
- d. Submit the list of target recipients with their respective proposed livelihood to the Local Government Unit.
- e. Assess the feasibility of the proposed livelihood.
- f. Certify the target beneficiaries.
- g. Accomplish Livelihood Recovery Project Proposal (LRPP) with assistance from Sustainable Livelihood Program- Regional Program Management Office (SLP. RPMO) to secure funding for the planned rehabilitation and recovery projects.

SECTION 4 – EFFECTIVITY. This order shall take effect immediately.
