## EXECUTIVE ORDER NO. 2 Series of 2025

## REACTIVATING THE BUSINESS ONE-STOP SHOP (BOSS) FACILITY FOR BUSINESS REGISTRATION IN THE MUNICIPALITY OF CALASIAO

WHEREAS, DILG-DTI-DICT JM. No. 01, Series of 2016, dated August 30, 2016, provides the Revised Standards in Processing Business Permits and Licenses in all cities and municipalities;

WHEREAS, par. 6.3. of said guidelines in setting up a BOSS Facility for Business Registration states that municipalities must set up a BOSS Facility whose layout supports the proposed steps in business permit processing which includes both frontline services and backroom operations in which the latter allows co-location of all concerned departments and national agencies specifically the Bureau of Fire Protection (BFP) in the BPLS system to receive and process applications for business registration;

**NOW, THEREFORE, I, KEVIN ROY Q. MACANLALAY,** Municipal Mayor of Calasiao, Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1.** REACTIVATION OF THE BOSS FACILITY. The Calasiao Business-One-Stop-Shop (BOSS) is hereby activated and shall be re-activated every first month of the year at the Economic Enterprise Office at the Business-One-Stop-Shop Building, Mabini St., Poblacion West, Calasiao, Pangasinan.

**SECTION 2.** DESIGNATION. Ms. Maria Victoria P. Del Rosario, Market Supervisor V, is hereby designated as Business Permit and Licensing Officer who will be in-charge of the processing and issuance of business permits and the proper collection of taxes, fees and charges;

**SECTION 3.** CO-LOCATION OF THE BFP to the BOSS. The amended Fire Code of 2008 stipulates that a Fire Safety Inspection Certificate (FSIC) must be secured by business applicants as a prerequisite for the issuance of the Business Permit. Pursuant to the abovementioned JMC, in compliance to all National Laws and Regulatory Requirements, the local BFP shall co-locate with the municipality to assess and collect the "ordinary" fire safety inspection fees (FSIF).

**SECTION 4.** MANNING. The representatives from the following offices shall be present in the BOSS, namely: Business Permit and Licensing Section, Municipal Engineering Office/ Zoning Office, Sanitary Office, Treasury Office, and BFP.
