RE-CONSTITUTING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL

WHEREAS, the constitution mandates that the government shall promote the quality of life of the people;

WHEREAS, Section 16 of the Local Government Code of 1991 provides that LGU shall pursue undertaking to improve public morals and maintain peace and order;

WHEREAS, the use of illegal drugs still remains a serious threat to our health, well-being, and national security;

WHEREAS, Joint Memorandum Circular No. 2018-01 sets out the Implementing Guidelines on the functionality, effectiveness and composition of the Local Anti-Drug Abuse Councils;

WHEREAS, with the recent developments in the Municipality of Calasiao, there is a need to reconstitute the Municipal Anti-Drug Abuse Council;

NOW THEREFORE, KEVIN ROY Q. MACANLALAY, Municipal Mayor of the Municipality of Calasiao, Pangasinan by virtue of the powers vested in me by law, do hereby order the following:

Section 1. Creation and Composition of the Municipal Anti- Drug Abuse Council. The Municipal Anti-Drug Abuse Council of Calasiao Pangasinan shall be composed of:

Section 2. *Duties and Functions*. The functions of the MADAC of Calasiao, Pangasinan are as follows:

1. Serve as focal point through which various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;

2. Provide for an effective mechanism for the coordination of existing services and programs and these which might be developed in the immediate future;

3. Provide for a mechanism to obtain funds, volunteers facilities and technical expertise; and

4. Perform other related responsibilities as may be assigned by competent authorities;

Section 3. *Funding*. The Sangguniang Bayan of Calasiao, Pangasinan is hereby requested to aside funds which may be necessary to carry out the above specific roles and responsibilities in pursuance of this order.

Section 4. Effectivity. This order shall take effect immediately.
