EXECUTIVE ORDER NO. 9

**AN ORDER MANDATING THE UPDATING OF THE COMPREHENSIVE LAND
USE PLAN FOR THE MUNICIPALITY OF CALASIAO, PANGASINAN**

WHEREAS, the existing Comprehensive Land Use Plan of Calasiao covering the period of 2014-2023 is about to expire and needs updating;

WHEREAS, as provided for under Section 20 (c) of R.A. 7160 or the Local Government Code of 1991, *“The local government units shall, in conformity with existing laws, continue to prepare their respective comprehensive land use plans enacted through zoning ordinance which shall be the primary and dominant bases for the future use of land resources: Provided, that the requirements for food production, human settlements, and industrial expansion shall be taken into consideration in the preparation of such plans”*;

WHEREAS, Executive Order No. 72 Section 1 (a) provides that *“Cities and municipalities shall continue to formulate or update their respective Comprehensive Land Use Plans, in conformity with the land use planning standards and guidelines prescribed by the Housing and Land Use Regulatory Board pursuant to national policies”*;

WHEREAS, R.A. 7160 further provides that the Local Development Council (LDC) is the body mandated by the Local Government Code of 1991 (LGC) to prepare the multi-sectoral development plan of a local government unit (LGU) thus it is critical to ensure that the LDC, as well as its functional and sectoral committees, as providers of technical support and assistance are constituted and activated, including the technical group for that purpose;

NOW, THEREFORE, I, KEVIN ROY Q. MACANLALAY, Municipal Mayor of the Municipality of Calasiao, Province of Pangasinan, by virtue of the powers vested in me by law, do hereby identify and mobilize the Comprehensive Land Use Plan (CLUP) team, to wit:

Section 2. FUNCTIONS AND DUTIES OF THE CLUP TEAM

(a) CLUP Project Steering Committee. The CLUP Project Steering Committee shall be created to serve as a policy body on the updating of the Comprehensive Land Use Plan.

(b) Planning Core Group. In support to the CLUP Project Steering Committee, a Planning Core Group shall be organized. All staff of the Municipal Planning and Development Office shall be constituted as support staff to the Planning Core Group.

The Planning Core Group shall be the overall committee responsible for coordinating all technical and administrative activities in the preparation of the CLUP, including stakeholder consultations and meetings. It shall also facilitate the presentation of the draft CLUP to the LDC for endorsement to the Sangguniang Bayan.

(c) Planning Technical Working Group. To facilitate the CLUP formulation process, a Technical Working Group shall also be created. All Department Heads and Section Heads of the different offices within the Local Government Unit of Calasiao and other National Government Agency Heads operating in the municipality are hereby constituted as the CLUP Technical Working Group and shall extend support to the Planning Core Group such as, but not limited to the following:

- (1) Provision of the necessary data requirements as per CLUP guidelines;
- (2) Conduct sectoral/ intersectoral analysis, validation, and reports;
- (3) Conduct surveys, consultations/ meetings, and workshops; and
- (4) Integration/ finalization of studies, research findings, and consultation/ survey outputs.

Section 3. RELATIONSHIP WITH THE LOCAL DEVELOPMENT COUNCIL AND OTHER UNITS

The CLUP Team shall work closely with the Local Development Council as soon as it is reconstituted. The Local Development Council shall act as the reference group for the CLUP team and shall participate actively, through its representative, in all stages of the CLUP process.

Section 4. SUPPORT REQUIREMENTS

The team may call upon the assistance of relevant units and /or Local Government Unit personnel, through the representative department/ unit heads, in the implementation of various activities relative to the formulation of the CLUP.

Moreover, everyone is enjoined to participate in the various activities of the CLUP team.
