EXECUTIVE ORDER NO. 9-A

**AN ORDER MANDATING THE UTILIZATION OF MUNICIPAL
SURVEY DATA FOR OFFICIAL PLANNING PURPOSES BY THE
LOCAL GOVERNMENT UNIT OF CALASIAO STARTING 2024**

WHEREAS, the Local Government Unit (LGU) of Calasiao recognizes the importance of evidence-based decision-making to ensure effective governance and sustainable development;

WHEREAS, a comprehensive municipal survey was conducted to gather relevant data on demographics, socio-economic conditions, infrastructure needs, and other critical factors affecting the municipality;

WHEREAS, the gathered data provides valuable insights that are essential for crafting informed policies, programs, and projects that align with the development goals of the municipality;

NOW, THEREFORE, I, **KEVIN ROY Q. MACANLALAY**, by virtue of the powers vested in me by the laws of the Republic of the Philippines, do hereby order as follows:

SECTION 1. Utilization of Municipal Survey Data. The data and findings derived from the municipal survey shall be officially adopted and utilized by the Local Government Unit of Calasiao for planning, policymaking, and implementation purposes starting from the year 2024 and onwards.

SECTION 2. Scope of Application.

1. The data shall serve as the primary reference for the development of the Comprehensive Land Use Plan (CLUP), Annual Investment Plan (AIP), Local Development Plan (LDP), and other related planning documents.
2. All departments and offices of the LGU are directed to incorporate the survey data in their respective operational and strategic planning processes.

SECTION 3. Monitoring and Evaluation.

1. The Municipal Planning and Development Office (MPDO) shall oversee the proper integration of the survey data into official plans and programs.
2. Regular progress reports on the application of the data in planning activities shall be submitted to the Office of the Mayor.

SECTION 4. Access to Data.

1. The municipal survey data shall be made accessible to relevant LGU offices and stakeholders for official use only, subject to existing data privacy laws and regulations.
2. Requests for data access by external entities shall require prior approval from the Office of the Mayor.

SECTION 5. Effectivity. This Executive Order shall take effect immediately upon its issuance and shall remain in force unless otherwise repealed or amended.
