EXECUTIVE ORDER NO. 10 Series of 2025

REORGANIZING THE MUNICIPAL CBMS COORDINATING BOARD AND THEIR TERM OF REFERENCE

WHEREAS, Republic Act No. 11315 otherwise known as Community-Based Monitoring System Act (CBMS Act) was enacted on 17 April 2019, institutionalizing the conduct of the Community-Based Monitoring System (CBMS) in every city and municipality in the country;

WHEREAS, Section 14 of the Act provides for the creation of the CBMS Council composed of the Philippine Statistics Authority (PSA), Department of the Interior and Local Government (DILG), and Department of Information and Communications Technology (DICT), to be headed by the PSA, for purposes of achieving secure and efficient data sharing arrangements between and among concerned cities and municipalities and national government agencies to be used for their particular social protection and welfare programs and projects;

WHEREAS, CBMS Council Resolution No. 06, Series of 2021 approved the establishment of the Provincial and City/Municipal CBMS Coordinating Boards (P/C/MCCBs) and their Terms of Reference;

WHEREAS, CBMS Council Resolution No. 01, Series of 2022 approved that Local Chief Executives shall serve as Chairpersons of the P/C/MCCBs while the PSA Representatives serves as Co-Chairpersons;

NOW, THEREFORE, I, KEVIN ROY Q. MACANLALAY, Municipal Mayor of the Municipality of Calasiao, Province of Pangasinan, by virtue of the powers vested in me by law, do hereby identify and mobilize the Municipal CBMS Coordinating Boards (MCCBs) members, to wit:

- (b) Resolve issues and concerns encountered in the conduct of CBMS. For issues that cannot be resolved at the city/municipal level, escalate to the Provincial CBMS Coordinating Board.
- (c) Facilitate the approval and timely release of funds (if any) and or other requirements for the conduct of CBMS.
- (d) Issue communications, directives, instructions, and/or circulars to cooperate mobilize and provide support/assistance to the CBMS operations in areas but not limited to the conduct/provision of the following:
 - i. Active participation in coordination meetings and activities
 - ii. Publicity and information campaign for the conduct of CBMS

iii. Venue for the training conduct, headquarters for the enumeration personnel and machine processing

iv. Transportation facilities for the enumeration personnel, and transport of CBMS forms, supplies and materials

v. Communication and wireless internet connection

vi. Storage area for tablets, forms and other materials

vii. Health and legal services to CBMS personnel

viii. Facilitation of enumeration in government-owned and private institutions and other hard-to-reach areas

ix. Take up other matters as necessary for the successful conduct of the C BMS

Section 3. EFFECTIVITY

The MCCB members shall exercise their functions and duties, effective immediately and until the project closes.
