EXECUTIVE ORDER NO. 18 Series of 2025

RE-CONSTITUTING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL

WHEREAS, the constitution mandates that the government shall promote the quality of life of the people;

WHEREAS, Section 16 of the Local Government Code of 1991 provides that LGU shall pursue undertaking to improve public morals and maintain peace and order;

WHEREAS, the use of illegal drugs still remains a serious threat to our health, well-being, and national security;

WHEREAS, Joint Memorandum Circular No. 2018-01 sets out the Implementing Guidelines on the functionality, effectiveness and composition of the Local Anti-Drug Abuse Councils;

WHEREAS, with the recent developments in the Municipality of Calasiao, there is a need to reconstitute the Municipal Anti-Drug Abuse Council;

NOW THEREFORE, KEVIN ROY Q. MACANLALAY, Municipal Mayor of the Municipality of Calasiao, Pangasinan by virtue of the powers vested in me by law, do hereby order the following:

Section 1. *Creation and Composition of the Municipal Anti- Drug Abuse Council*. The Municipal Anti-Drug Abuse Council of Calasiao Pangasinan shall be composed of:

Section 2. *Duties and Functions*. The functions of the MADAC of Calasiao, Pangasinan are as follows:

- 4. Perform other related responsibilities as may be assigned by competent authorities;
