#### EXECUTIVE ORDER NO. 22 Series of 2025

# AN ORDER CREATING THE PEOPLES' COUNCIL IN THE MUNICIPALITY OF CALASIAO, PANGASINAN.

WHEREAS, Article II, Section 23 of the 1987 Philippine Constitution provides, "The State shall encourage non-governmental, community-based or sectoral organization that promote the welfare of the nation";

WHEREAS, Article XIII, Section of the same 1987 Philippine Constitution further professed that the State shall respect the role of independent people's organizations to enable the people to pursue and protect, within the democratic framework, their legitimate and collective interest and aspirations through peaceful and lawful means;

WHEREAS, the People's Council is a way to provide mechanism by which citizens' view and opinions may be heard and considered in relation to different ideas of governance;

WHEREAS, the Local Government Units play a major role in a community's development, provide the links between people and government, address its community's concerns, and enforce policies and help influence over its communities;

WHEREAS, Section 34, of R.A. No. 7160, otherwise known as the Local Government Code of 1991 provides that, "Local Government Units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, people's participation will make society organizations more involved in the local governance and create an environment where people can participate in policy and decision-making processes;

NOW, THEREFORE, I, KEVIN ROY Q. MACANLALAY in consideration of the foregoing premises and by virtue of the power vested in me by law as the Municipal Mayor of Calasiao, do hereby constitute the composition of the Peoples' Council in the Municipality of Calasiao, Pangasinan;

**Section II.** Roles and Responsibilities. The Peoples' Council shall have the following Roles and Responsibilities:

1. Mobilize and ensure participation of CSOs in local governance processes;

2. If allowed by Sanggunian, propose legislation and participate and vote at the committee level;

- 3. Ensure independence of the Council;
- 4. Have a representative in the Provincial People's Council.

**Section III.** Term of Office. The term of office of the Peoples' Council should be coterminous with the term of the present administration.

Section IV. Effectivity. This executive Order shall take effect immediately upon signing.
