### **MUNICIPALITY OF CALASIAO**

SECTION 3. Functions. The Task Force on Environmental Protection shall perform the following functions:

- 2. Ensure the maintenance of cleanliness in the Municipality of Calasiao, Pangasinan.
- 3. See to it that the management of solid waste in the Municipality of Calasiao, Pangasinan is properly carried out.
- 4. Implement the environmental laws in the Municipality of Calasiao, Pangasinan
