**CREATING THE MUNICIPAL COUNCIL FOR THE PROMOTION OF
CULTURE AND THE ARTS IN THE MUNICIPALITY OF CALASIAO,
PANGASINAN**

WHEREAS, history and culture are essential dimensions of human existence because in every group or nation, there is an ever-increasing number of men and women who have become artisans and authors of the culture of their own community;

WHEREAS, Section 16 of the Local Government Code of 1991 provides that Local Government Unit shall ensure and support the preservation and enrichment of Filipino culture;

WHEREAS, Section 447 (5) (XVI), 458 (5) XVI, 468 (4) VIII of RA 7160 rest upon local Sanggunian the power to establish local council whose purpose is the promotion of culture and the arts;

WHEREAS, the council will plan for the promotion of the Filipino culture, instill nationhood and cultural unity, raise the level of consciousness of the people on cultural unity, raise the level of consciousness of the people on cultural values, conservation of historical and cultural heritage and resources;

NOW THEREFORE, I, KEVIN ROY Q. MACANLALAY, Municipal Mayor of Calasiao, under the power and authority vested in me do hereby ordain and decree that:

SECTION I. CREATION – There is hereby created a Municipal Culture and the Arts Council to be composed of the following:

SECTION II. FUNCTIONS – The Local Council for Culture and the Arts shall have the following functions:

- Prepare an annual cultural and arts plan to be integrated with the local development plan;
- Formulate programs and recommendations to develop local cultural and artistic talents;
- Ensure the protection, preservation, and conservation of the local, cultural, and historical heritage;
- In coordination with the private sector, conduct cultural events such as cultural festivals, competitions, lectures, seminars, tours, and symposiums; set up exhibits during fiesta and other related activities.

SECTION III. SECRETARIAT. A secretariat for the Council is hereby constituted, headed, by the tourism officer for operations, which shall be responsible for providing technical support, documentation of proceedings, preparations of reports, and such other assistance as may be required in the discharge of functions of the Council.

SECTION IV. EFFECTIVITY. This executive order shall take effect immediately.
