EXECUTIVE ORDER NO. 48 Series of 2024

ORGANIZING PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF CALASIAO

WHEREAS, Republic Act 6975, otherwise known as an Act Establishing the Philippine National Police, mandates the creation of a People's Law Enforcement Board (PLEB) in every local government unit;

WHEREAS, the Sangguniang Bayan, issued Resolution No.135 series of 2023 apropos the People's Law Enforcement Board for the Town of Calasiao;

WHEREAS, Section 43 of R.A. 6975, provide for the composition of the PLEB, viz:

(a) Composition and term Office of the PLEB shall be composed of the following:

Any member of the Sangguniang Panlungsod/Bayan chosen by the Sanggunian.
Any barangay Captain of the City or municipality concerned chosen by the

Association of Barangay Captains, and

3. Three (3) other members who shall be chosen by the peace and order council Among the respected members of the community known for their probity and Integrity, one (1) of whom must be a member of the Bar or in the absence thereof,

A college graduate or the principal of the elementary school in the local.

NOW, THEREFORE, I, **HON. KEVIN ROY Q. MACANLALAY**, by virtue of the power vested in me by law, do hereby order as follows:

SECTION 1. REORGANIZATION. The People's Law Enforcement Board of Calasiao is hereby reorganized by virtue of this executive order.

SECTION 2. COMPOSITION. The reorganized People's Law Enforcement Board shall be composed of the following:

SECTION 3. POWERS AND DUTIES. The PLEB shall have jurisdiction to hear and decide citizen's complaints or cases filed before it against erring officers and member of the PNP, and to impose the corresponding penalty.

Decision of the PLEB shall become final and executory; Provided, that a decision involving demotion or dismissal from the service may be appealed by either party with the regional appellate board.

SECTION 4. COMPENSATION. Membership on the PLEB is a civic duty. However, the PLEB member hereof are given **HONORARIUM/PER DIEM of ONE THOUSAND PESOS (Php. 1,000.00)** per session, as provided in the municipal annual budget.
