**DECLARING SUSPENSION OF CLASSES IN ALL LEVELS  
IN PUBLIC AND PRIVATE SCHOOLS AND WORK IN THE  
LGU AND PUBLIC EDUCATIONAL INSTITUTIONS IN  
CALASIAO IN CELEBRATION OF THE PUTO FESTIVAL**

**WHEREAS**, cultural activities in the Municipality of Calasiao shall herald the forthcoming Calasiao Puto Festival;

**WHEREAS**, the cultural activities are meant to promote the municipality's pride—the puto, and to ignite tourism and economy;

**WHEREAS**, the Local Government Unit acknowledges that the active participation of the studentry and the faculty is indispensable in the municipality's most important cultural event of the year;

**WHEREAS**, in the conduct of the activities on December 9, 2024, public order and convenience ought to be ensured by the Local Government Unit necessitating the suspension of classes for local public and private schools;

**WHEREAS**, Section 16 of Republic Act No. 7160 or the Local Government Code provides that:

SECTION 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the **preservation and enrichment of culture**, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, **maintain peace and order, and preserve the comfort and convenience of their inhabitants.**

**NOW THEREFORE, I, KEVIN ROY Q. MACANLALAY**, Municipal Mayor of Calasiao, Pangasinan, by virtue of the powers vested in me by law hereby declare the **SUSPENSION OF CLASSES IN ALL LEVELS IN PUBLIC AND PRIVATE SCHOOLS AND WORK IN THE LGU CALASIAO AND PUBLIC EDUCATIONAL INSTITUTIONS IN CALASIAO, PANGASINAN** on December 9, 2024.
