RE-ALIGNING CERTAIN APPROPRIATED AMOUNTS

**WHEREAS**, the Local Government Code 1991 empowers the mayors to provide expenditures necessary for the proper conduct of programs, projects, services, and activities of the local government unit essential towards achieving its common goals and objectives;

**WHEREAS**, in accordance with Section 336 of Republic Act No. 7160, of the Local Government Code of 1991, the Municipal Mayor and the Vice Mayor are authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriation;

**WHEREAS**, the allotted amount for certain expenses has exceeded the actual amount needed for the whole year as the case herein and as herein set forth.

**WHEREAS**, by virtue of Annual Budget 2023 the Municipal Mayor is empowered or authorized under "Use of Savings and Augmentation" to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;

**NOW, THEREFORE, I, KEVIN ROY Q. MACANLALAY**, by the power vested in me by the law, hereby authorized, through this Executive Order, the re-alignment as follows:
