APPROPRIATION ORDINANCE NO. 01, SERIES OF 2020 Sponsored by: COUN. ARDIESON B. SORIANO

AN ORDINANCE AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 01, OF LGU CALASIAO FOR FISCAL YEAR 2020 IN THE TOTAL AMOUNT OF TWENTY FOUR MILLION FIVE HUNDRED THIRTY FIVE THOUSAND EIGHT HUNDRED SIXTY SIX PESOS (P24,535,866.00) FOR GENERAL FUND PROPER AND FOUR HUNDRED FIFTY THOUSAND PESOS (P450,000.00) FOR ECONOMIC ENTERPRISE, SPECIAL ACCOUNT COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE MUNICIPAL GOVERNMENT OF CALASIAO AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

Be it ordained in regular session assembled:

Section 1. The Supplemental Budget of Municipality of Calasiao, Pangasinan for Fiscal Year 2020 in the total amount of TWENTY FOUR MILLION NINE HUNDRED EIGHTY FIVE THOUSAND EIGHT HUNDRED SIXTY SIX PESOS (P24,985,866.00) for General Fund and Economic Enterprise, special account is hereby approved.
