Brief Explanation Note

The position of Rural Health Physician has already been devolved and is no longer allowed by the Civil Service Commission. Thus, it has been changed to Medical Officer IV since it is no longer applicable to be used by the LGU; and Administrative Asst. III (Stenographer III), is also no longer necessary. The duties/responsibilities of said employees are redundant. The job could be performed more effectively by the head of office themselves.

Since the positions/items to be abolished are vacant, no occupant or employee will be adversely affected.
