APPROPRIATION ORDINANCE NO. 04, SERIES OF 2020 Sponsored by: COUN. JERALD C. NAVARRO

WHEREAS, Section 4, of Republic Act 11469 also known as "(Bayanihan to Heal as One Act) granted the President Rodrigo Roa Duterte the power to adopt various temporary emergency measures to respond to crisis brought about by the Coronavirus Disease 2019 (COVID-19) pandemic;

WHEREAS, President Rodrigo R. Duterte has approved the "Bayanihan Grant to Cities and Municipalities" which is equivalent to one month of a Local Government Unit's (LGU) Internal Revenue Allotment to provide funds and assistance to Cities And Municipalities to help their relief and response efforts against the Coronavirus Disease 2019 (Covid-19);

WHEREAS under the guidelines of the Local Budget Circular 125 of the DBM dated April 7, 2020 the utilization of the BGCM shall be subject to the usual local budgeting process pursuant to the pertinent provisions of the Local Government Code of 1991 (RA 7160);

WHEREAS, the guidelines also provides under 3.5 and 3.6 of the Local Budget Circular No. 125, the allowed used and expenses and non allowed used and expenses of the Barangay Grant to Cities and Municipalities;

WHEREAS, the Municipality will create a special account in the general fund for the Bayanihan Grant to Cities and Municipalities with corresponding subsidiary ledger that will reflect the fund transfer and detail of the corresponding expenses.

WHEREFORE, upon motion duly seconded, the body hereby approved this Ordinance to wit:

APPROPRIATION ORDINANCE NO. 04, SERIES OF 2020

AN ORDINANCE AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 04 OF LGU CALASIAO FOR FISCAL YEAR 2020 IN THE TOTAL AMOUNT OF EIGHTEEN MILLION FOUR HUNDRED FORTY TWO THOUSAND THREE HUNDRED SEVENTY FIVE PESOS (P18,442,375.00) FOR THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM) AND THE CREATION OF THE CORRESPONDING SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) FOR PURPOSES OF THE GRANT.

Be it ordained in regular session assembled that:

Section 1. The Supplemental Budget of Municipality of Calasiao, Pangasinan for Fiscal Year 2020 in the total amount of EIGHTEEN MILLION FOUR HUNDRED FORTY TWO THOUSAND THREE HUNDRED SEVENTY FIVE PESOS (P18,442,375.00) for General Fund and special account is hereby approved.

The Budget documents consisting of the following are incorporated herein and made integral part of this Ordinance:

Section 2. Sources of Funds. The sources of funds for the Supplemental Budget in the total amount of EIGHTEEN MILLION FOUR HUNDRED FORTY TWO THOUSAND THREE HUNDRED SEVENTY FIVE PESOS (P18,442,375.00) shall be as follows:

Section 3. Use of Funds. The amount of EIGHTEEN MILLION FOUR HUNDRED FORTY TWO THOUSAND THREE HUNDRED SEVENTY FIVE PESOS (P18,442,375.00) is hereby appropriated for the Supplemental Budget of the Municipality of Calasiao, Pangasinan, as follows:
