AN ORDINANCE ESTABLISHING THE SCHOLARSHIP PROGRAM OF THE MUNICIPALITY OF CALASIAO, PANGASINAN

WHEREAS, the Philippines Constitution under Article XIV, section 1 provides that the state shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all;

WHEREAS, the Philippine Constitution under Article I, section 17 provides that the state shall give priority to education, science and technology, arts, cultures and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

WHEREAS, Article XIV, section 2 par 3, provides that the state shall establish and maintain a system of scholarship grants, student loan programs, subsidies and other incentives which shall be available to deserving students in both public and private schools, especially the underprivileged;

WHEREAS, Republic Act 7160, Section 447, par 5 sub par. XI provides that the Sangguniang Bayan shall enact ordinances establishing scholarship fund for poor but deserving students residing within the municipality in schools located within its jurisdiction;

WHEREAS, in view of the foregoing, this august body establishes the Scholarship Program of the Municipality of Calasiao, Pangasinan for poor, under privileged and deserving students for them to attain higher degree of education;

NOW THEREFORE, on joint motion of Coun. Manny V. Datuin and Coun. Nestor A. Gabrillo, duly seconded by all members it was,

BE IT ORDAINED by the Sangguniang Bayan of Calasiao in regular session assembled

SECTION 1. TITLE: The title of this ordinance shall be "An Ordinance Establishing the Scholarship Program of the Municipality of Calasiao, Pangasinan"

SECTION 2. SCOPE: The Scholarship program of the Municipality of Calasiao, Pangasinan is aimed to support poor, under privileged and deserving students residing within the Municipality of Calasiao.

SECTION 3. QUALIFICATIONS:

- a. The applicant must be a natural born Filipino citizen, of good moral character, and a resident of the Municipality of Calasiao, Pangasinan.
- b. At the time of application the applicant must have a general average of eighty (80%) percent or its equivalent in all subjects during the preceding school year or semester.
- c. The applicant shall be a registered voter of Calasiao, Pangasinan.
- d. APPLICANT MUST BELONG TO AN INDIGENT FAMILY. It is understood that an indigent family, are those who have no means of income or whose income is insufficient for family subsistence. This fact can be certified by the Barangay Chairman or by the Municipal Social Welfare and Development Officer.
- e. The applicant's family shall not have a monthly net income of P15,000.00 or more.
- f. Only one (1) member of the family per school year/semester shall be given a scholarship grant from the Local Government Unit of Calasiao.
- g. The applicant shall be enrolled to a government or private, CHED accredited institutions.
- h. Applicants with complex conditions such as but not limited to, disabilities, orphans, or with single parent shall be given priority.

SECTION 4. DOCUMENTARY REQUIREMENT:

- a. Bio data with two (2) 2x2 ID Pictures
- b. Photocopy of report card
- c. Voter's IDd. Photocopy of Birth Certificate
- e. Certification from the Punong Barangay stating that the applicant is a resident and belongs to an indigent family of the barangay for the scholarship grant.
- f. Certificate of Good Moral Character from the School Director/Principal/Dean President/ or Registrar's Office
- g. ITR or any proof of income of Parents or Guardians

SECTION 5. INSTITUTION AND COURSE: A qualified scholarship grantee shall have full right to choose which institution and course he/she wishes to enroll, duly recognized by the Department of Education and the Commission on Higher Education.

SECTION 6. SCHOLARSHIP GRANT: The scholar grantee shall continue to benefit from the scholarship grant of the Local Government Unit of Calasiao, Pangasinan provided that he/she should not get a general average lower than eighty (80%) percent or its equivalent in any academic course or dropped mark in any subject during a preceding or current school vear/semester. Provided further, that if the Scholar grantee failed to any subject due to health. consideration would be given but a medical certificate should be submitted to justify the failed subject.

SECTION 7. AMOUNT OF SCHOLARSHIP GRANT. Every scholarship grantee in college (degree or non degree) shall receive Five Thousand Pesos (P5,000.00) to cover his/her tuition fees and subsistence allowance if any.

SECTION 8. MODE OF PAYMENT. The Scholarship Grant shall be paid directly to the schools where the grantee is enrolled or directly to the grantee. In case there is an excess from the amount paid to the school per scholarship grantee, the school shall reimbursed immediately the excess amount to the grantee or to the local government unit of Calasiao, Pangasinan.

SECTION 9. SCHOLARSHIP GRANT CLAUSE. The scholarship grant shall cover one (1) semester/academic year. The scholar shall renew their applications for the scholarship grant every start of the school year or semester until they have completed their college degree in a public or private school/college/university subject to the following conditions:

- a. The grantee shall enroll immediately to the school/college/university before or at the start of the school year/semester following the approval of his/her scholarship grant.
- b. The grantee shall enroll the full load/units per academic year/semester prescribed by the school for every school grade/level.
- c. The grantee may be allowed to change course or transfer to another school provided that the transfer is initiated by the grantee and not the current school due to disciplinary or academic issues.

SECTION 10. GROUNDS FOR TERMINATION OF SCHOLARSHIP GRANTS.

- a. Incomplete submission of Documentary Requirements;
- b. Academic Deficiencies;
- c. Falsifying official records and grades;
- d. Record of misconduct of a student in schools and the community;
- e. Absences beyond the allowable number of absences set by the school where he or she is enrolled; and
- f. Conviction of a crime involving moral turpitude.

SECTION 11. ADMINISTRATION. The scholarship grantee shall undergo the interviews of the Scholarship program council.

- a. There shall be a Municipal Scholarship Council to be designated by the Local Chief Executive to manage and oversee the implementation of the Scholarship Program.
- b. The Scholarship program shall continue to benefit qualified students until they have finished their college degree within the prescribed period of the course he/she chooses to take.
- c. A Memorandum of Agreement shall be made to serve as a legal parameter for the implementation of the scholarship program to be signed by the Local Government Unit of Calasiao, represented by the Municipal Mayor as the first party and the School/College/University Principal, Heads, Presidents or Director as the second party.

SECTION 12. MUNICIPAL SCHOLARSHIP COUNCIL. The Local Chef Executive shall create a Municipal Scholarship Council whose function is to screen and evaluate applicants for the scholarship grants. The Municipal Mayor shall be the Chairman of the Calasiao Scholarship Council. The Sangguniang Bayan Chairman of Committee on Education as Vice Chairman. Other members of the Council shall be determined by the Local Chief Executive.

SECTION 13. APPROPRIATIONS. The amount of Six Million Pesos (P6,000,000.00) shall be included in the Annual Budget of the Municipality of Calasiao as Scholarship/Financial Assistance Program Fund.

SECTION 14. SEPARABILITY CLAUSE. If for any reason and any portion or provision of this ordinance is declared unconstitutional or invalid, such other sections or provisions thereof which are not affected shall continue to be in full force and effect.

SECTION 15. REPEALING CLAUSE. All Ordinances, or parts thereof, which are inconsistent with any provision of this ordinance, are hereby repealed, amended, or modified accordingly.

SECTION 16. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon its approval and compliance on posting and publication.
