AN ORDINANCE AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 2, OF LGU CALASIAO FOR FISCAL YEAR 2021 IN THE TOTAL AMOUNT OF FIFTEEN MILLION FOUR HUNDRED FOURTY FIVE THOUSAND NINE HUNDRED EIGHTY ONE PESOS AND SIXTY SEVEN CENTS (P15,445,981.67) FOR GENERAL FUND PROPER AND FOR THE OPERATION OF THE MUNICIPAL GOVERNMENT OF CALASIAO AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.
