AN ORDINANCE TRANSFERRING THE POSITION OF ADMINISTRATIVE AIDE I (UTILITY WORKER – I) WITH SALARY GRADE 1, FROM THE PUBLIC EMPLOYMENT AND SAFETY OFFICE (PESO) TO THE GENERAL SERVICES OFFICE (GSO).

Explanatory note

The above mentioned item and position is not Vacant – meaning someone is occupying it. Then came the Memorandum from the Mayor's Office dated October 14, 2021 transferring her assignment from the Public Employment and Safety (PESO Office) to the General Services Office (GSO).

SECTION 1 – Be it enacted by the Sangguniang Bayan of Calasiao, Pangasinan that the position Administrative Aide 1 with Salary Grade 1, is hereby transferred from the Public Employment and Safety (PESO Office) to the General Services Office (GSO) - Municipality of Calasiao, Pangasinan;

SECTION II- This Ordinance shall take effect immediately upon approval by the Sangguniang Panlalawigan.






