AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 04, OF LGU CALASIAO FOR FISCAL YEAR 2018 IN THE TOTAL AMOUNT OF ONE HUNDRED TWENTY TWO MILLION SEVEN HUNDRED ONE THOUSAND SEVEN HUNDRED TWENTY-THREE PESOS AND SIXTEEN CENTAVOS (P 122,701,723.16) FOR GENERAL FUND PROPER, FOR THE OPERATION OF THE MUNICIPAL GOVERNMENT OF CALASIAO AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.
